## INTRODUCTION

As you take part in the rapidly growing freelance economy, you of course want to make sure that you're charging a rate that is appropriate for your skills, education and experience.

This survey was conducted with 23,006 responses from freelancers worldwide, of which 1,973 were based in India. The rates that appear in this survey reflect the hourly rates charged by each respondent. This survey allows you to compare your average hourly freelancing rates to your industry peers, better understand what drives compensation in this hyper-competitive market, and learn how to increase your overall income. All survey results are presented in U.S. dollars.

#### **KEY FINDINGS**


- ► The average hourly rate charged by freelancers in India is \$19
- Almost half of the clients that Indian freelancers work with are based in Asia
- Freelancers providing legal services charge more than any other service (\$31/hour)
- Over three quarters of Indian respondents are male (78%)
- Male Indian freelancers charge an average of 11% more than females.
- lndividuals working at companies charge 5% more than freelancers working independently at home.
- Indian professionals work on their freelance projects an average of 37 hours per week (7.5 hours per day for a 5-day work week), an hour more a week than the global average.
- ▶ The worldwide satisfaction level of freelancers is 46%, with Indian freelancers coming in at 36%.
- Indian professionals providing Sales & Marketing services work the most hours a week and also hold the highest level of income satisfaction.
- Indian freelancers who work in the field of Writing & Translation have the lowest level of income satisfaction but also have the fewest hours of work per week.

## METHODOLOGY

Survey results are based on 1,973 responses collected from Indian freelancers and a total of 23,006 freelancers worldwide through an online questionnaire commissioned by Payoneer during November and December 2014.


The analysis is based on all survey answers between \$1 at the lowest hourly rate and \$100 at the highest.

## WHO DID WE SURVEY?




Respondents represent a wide range of countries across the freelancing world with a primary focus on those from emerging markets in Asia, Latin America and Europe. 27% came from Asia, split primarily between India, Pakistan and Bangladesh.

### MALE VS. FEMALE



The vast majority of Indian freelancers are in their 20s and 30s (85%).

#### **EDUCATION LEVEL**



Almost half of the clients Indian freelancers are working with are based in Asia. The Americas are also an important region, with over a quarter of the professionals' clients residing there.

## WHO'S EARNING WHAT?

#### AVERAGE HOURLY RATE

The average hourly rate across all the 180 countries surveyed is \$21. The average hourly rate in India is slightly lower, with an average of \$19.

55% of Indian professionals charge under \$10 an hour for their work. 29% charge between \$11 and \$30, and 15% demand over \$30 per hour.

## AVERAGE HOURLY RATE BY SKILL


Not all freelancers were created equal! The income survey confirmed that certain skill types demand significantly more than others. Professionals in India providing legal services are charging a significantly higher hourly rate (\$32) than those in other areas of expertise.

Hourly rates are about average for IT & Programming (\$18) but below average for Writing & Translation (\$16).

#### AVERAGE HOURLY RATE BY GENDER

Men make up the vast majority of freelancers in India, and are also charging 11% more than female professionals.



#### AVERAGE HOURLY RATE BY EDUCATION

On average, freelancers with a higher level of education are charging more. This suggests that hiring companies and professionals do take education into account when selecting their freelancers, in addition to their experience, portfolio, and skills.




#### AVERAGE HOURLY RATE BY JOB SITUATION

Professionals working solely as independent freelancers charge 5% less than those working as a part of a company. This may result from the extra credibility that comes with doing business with a company rather than an independent freelancer.



#### AVERAGE HOURLY RATE BY WORKPLACE

In the same light, professionals working from offices charge 5% more than those working at home. This may be simply a necessary additional charge to cover office expenses that don't impact freelancers who work from their home.



## HOW HARD ARE YOU WORKING?

According to our survey, the average number of hours worked by professionals on freelancing jobs is 36 hours per week (7.2 hours per day for a 5-day work week). Indian professionals are among the most hard-working countries that were surveyed.


Professionals providing Sales & Marketing services work the most hours, with a high average of almost 42 hours per week. They are followed closely by freelancers providing Finance & Management or Legal services.

# HOW SATISFIED ARE FREELANCERS WITH THEIR INCOME?

The worldwide income satisfaction level is 46% with Indian freelancers coming in below average at 36%. Professionals in Sales & Marketing are not only the most hard working, but also hold the highest level of income satisfaction in India (followed closely by freelancers in Finance & Management, and IT & Programming), while those in Writing & Translation are at the lowest level of satisfaction as well as working the fewest hours per week. It appears that there is a direct correlation between hours of work and income satisfaction, suggesting that many freelancers would ideally like to find more work.

#### **INCOME SATISFACTION**


